Eye on the Sino-US trade war: South China Morning Post quoted sources as saying that US President Trump held talks with Chinese President Xi Jinping to end the trade war, and that may be postponed until June this year because they could not reach an agreement before May.

**Focus on results announcement:** The market focuses on the results of the big blue chip, and it is expected that the market has a high chance of short-term consolidation.

**Eye on the Fed rate meeting:** Fed will hold a meeting on Tue and Wed local time. Investors are concerned about Chairman Powell's statement of economic prospects, interest rate forecasts and any issues related the end of balance sheet trimming.

**WH Group (00288)** announced annual results ended December 2018. The turnover rose 1% YoY to USD22.605 bn. Net profit before biological fair value adjustments amounted to USD1.046 bn, down 4% YoY. Final DPS was HK15 cents.

**Fuyao Glass (03606)** announced annual results ended December 2018. The revenue rose 8.1% yoy to RMB20.225 bn. Net profit grew 30.9% yoy to RMB4.12 bn.
