Market Outlook

HSI expected to consolidate at around 28,500 today.

Alleviating concerns on US yield curve inversion: Worries about implications of yield curve inversion on macro slowdown diminish, boosting investment sentiment. Coupled with the benefits of the Venezuelan power outage affecting oil exports, OPEC restrictions on oil supply and market expectation on drop in US crude oil inventories, oil prices rise. US stocks rebound.

Sino-US trade war: Bloomberg on Tue (25th) quoted sources as saying that China plans to substantially increase US pork import, as part of its commitment to purchase US agricultural products, to speed up the trade agreement between the two countries.

We lower the rating of CR Power(00836) from "Buy" to "Hold", also dropping out of our focus stock list.
