### **Market Outlook**

HSI is expected to consolidate at around 30,200 today.

**Sino-US trade negotiations:** US White House economic adviser Kudlow said that there will be more talks this week, US and China continue to make good progress, including law enforcement issues. Reuters reported that China intends to lift the US poultry ban and purchase US pork imports.

Focus on China's GDP data and US corporate earnings: China's GDP will be announced this morning, and the market expects GDP growth to slow further to 6.3%. In addition, large companies such as IBM and Netflix will announce their results.

**Quarterly results announcement:** Our focus stock on China Tower (00788.HK) will announce its first quarter results today.

### Sector and Company News

**SSY Group (02205)**'s revenue for the first three months of 2019 grew 4.3% YoY to RMB925 mn.

China East Air (00670) announced the operating data for March 2019 that the number of passengers carried reached 10.6462 mn, up 5.4% YoY. For the first three months of 2019, the total number of passengers carried grew 10.9% YoY to 31.8777 mn.

The aggregate premiums income of PICC Group (01339) as derived from the operating subsidiaries PICC Property and Casualty Company Limited, PICC Health Insurance Company Limited and PICC Life Insurance Company Limited for first three months of 2019 were RMB125.463 bn, RMB9.108 bn and RMB58.661 bn, respectively. The total amount was RMB193.232 bn, up 13.6% YoY.

**PICC P&C (02328)** announced that the direct premium income for the period from 1 January 2019 to 31 March 2019 totaled RMB125.463 bn, up 18.29% YoY.

**Cathay PAC Air (00293)** announced that Cathay Pacific and Cathay Dragon carried a total of 3.1113 mn passengers in March 2019, an increase of 2.5% YoY. During the month, the two airlines carried 185,200 tonnes of cargo and mail, with a drop of 2.5% YoY.
